Outdoor shoes are not permitted in the dance studio. All street shoes MUST be removed and left at the door. Soft-soled, non-marking, clean dance shoes or footwear are allowed on the dance floor. Please note: no tap shoes, rosin, baby powder, flamenco shoes, body oils, lotions, or sharpedged shoes are permitted to be used on the dance floor. Extra costs apply for Marley overlay removal and restore.

Any sets, props, scenography or audio equipment that may come in contact with the dance floor must be non-damaging and may require rubber, carpet, or other material be used to ensure the dance floor is not scratched, marked or damaged.
